Local REALTORS® gift \$7,500 to benefit Hancock County homeless

This holiday season, the families served by Hancock Hope House have a little something extra to be thankful for.

This week, Hancock Hope House was presented with a check for \$7,500 from the REALTOR® Foundation. The funds will be used to support its Operation Access to Hope program, allowing the renovation of its shelter and store for handicapped accessibility.

“What’s most important about this grant is that it will allow Hope House to take the beginning steps toward meeting the accessibility needs of our community, including building handicapped accessible entrances to our thrift stores and residents’ doors” explained Ellie Delcomyn of Hancock Hope House. “We are truly blessed to receive these funds.”

In October, the REALTOR® Foundation announced a record-breaking \$80,000 in grants to 12 local charities that supply critical, emergency housing for victims of unforeseen circumstances.
